

# 2017 NORTHEAST FUTURITY – Exceptional Re-opening Nomination Form

***In addition to re-opening the 2018 Northeast Holstein Futurity to Milking Yearlings, we are also re-opening the 2017 Futurity.*** You can now nominate your Milking Yearlings and any new or additional Two Year Olds. Entries will be accepted immediately, with a one-time entry fee that stays with the animal, regardless of ownership. There are no limitations on the numbers of nominees from any exhibitor. Plan on being a part of history as we showcase the finest Two Year Olds and Milking Yearlings in the Northeast with **MINIMUM** prize monies of \$500 for our winner.

**PROCEDURE:** Complete owner information and entry blank on the reverse. Mail entry and check payable to New England States Holstein Association by **April 15, 2017.**

## RULES AND AWARDS

### **ELIGIBILITY for 2017 Northeast Holstein Futurity:**

Any Registered Holstein female (87%RHA or higher) that was born between September 1, 2014 and November 30, 2015 is eligible for the 2017 Northeast Futurity. An animal may only be shown once in this futurity; therefore, a milking yearling may not be entered again as a two-year old.

**FEES:** One-time Nomination Fee of \$50.00 postmarked by April 15, 2017.

### **SHOWING:**

In order to be eligible for any part of the purse, fees must have been made by the required date and the animal must be exhibited in a special Northeast Holstein Futurity Class held in conjunction with the Northeast Fall National Holstein Show in Springfield, MA. Animals must also be entered in their respective classes of the Northeast Fall National Holstein Show.

### **PURSE:**

The purse in this 2017 Northeast Holstein Futurity Class shall consist of sponsorships as well all monies received by the New England States Holstein Association in the form of Nomination Fees less any incidental expenses incurred for its promotion and management. The **MINIMUM** payout shall be as follows:

<u>Placing</u>	<u>Minimum payouts*</u>
1st Place	\$500
2nd Place	\$250
3rd Place	\$200
4th through 10th Place	\$150
11th through 20th Place	\$100

*\*Payouts will be supplemented by proportional disbursement of nomination fees.*

### **NO REFUNDS:**

All nomination fees are committed to the purse and no refunds will be made unless the Futurity Show is officially cancelled by the New England States Holstein Association, Inc.

### **TRANSFER OF OWNERSHIP OF ELIGIBLE ANIMALS:**

Any animal sold after being nominated initially will remain eligible provided the subsequent fees are paid as specified. In all cases, the responsibility of making required payments is the responsibility of the owner.

### **GENERAL:**

The New England States Holstein Association, through its elected officers, is sponsoring and governing the Futurity, and will make all decisions not covered by these rules. However, they will not be responsible for accident or injury to animal or person in connection with the show.
